

## Philadelphia's Magic Gardens: Rules and Policies

**Philadelphia's Magic Gardens is a mosaicked visionary art environment, gallery, and community arts center that preserves, interprets, and provides access to Isaiah Zagar's unique mosaic art environment and his public murals. For the safety of the artwork and guests, and to ensure the best possible visitor experience, we ask that you respect the following policies.**

### VISITOR EXPERIENCE:

- Please refrain from any type of soliciting on our premises.
- Playing music, shouting, foul language, and/or other disruptive activities are not permitted.
- Stairways and passageways must remain clear to all visitors.

### PERSONAL SAFETY:

- **There is no running, climbing, or rough play anywhere on PMG property.**
- Shirts and shoes must be worn at all times.
- Children must be supervised at all times. Anyone under 16 years of age will not be admitted without an adult.
- Be respectful of areas that are marked as not open to the general public. Do not enter these areas.
- During rainy weather, tiles become slippery. Please take care when walking through our outdoor space. Certain areas may be blocked off for safety purposes.
- No firearms or fireworks
- Scooters, wheelie shoes, and skateboards are not allowed
- Please keep your personal items with you at all times. PMG is not liable for any belongings that are lost, stolen, or broken during your visit to PMG. Any found items are kept in our office for a limited amount of time. Please call 215-733-0390 as soon as possible to see if your lost item has been recovered.

### PHOTOGRAPHY:

- Casual photography is encouraged; any photo shoots need to be scheduled in advance.

### ARTWORK:

- For the preservation of the space, we prefer that visitors refrain from touching the artwork.
- If visitors are caught damaging or vandalizing the artwork, PMG will contact the authorities.
- Please do not litter, as it can damage the artwork. This includes putting paper in the bottles outdoors.
- The Special Exhibitions showcased in our indoor galleries may not be touched or handled by anyone but a PMG staff member.
- Mosaics by Isaiah Zagar can be held for an interested buyer for a maximum of 24 hours without a non-refundable deposit.

### MEETINGS & GATHERINGS:

- Groups of over 20 who are interested in visiting PMG for a self-guided tour must call in advance.
- All private guided tours must be scheduled in advance. We recommend contacting our Education and Outreach Manager at least two weeks ahead of time to ensure availability.

- Formal and informal groups or parties are not allowed to hold meetings, weddings, memorial services, or classes at PMG without advanced notice and written permission.

#### FOOD AND DRINK:

- Visitors are welcome to bring food and/or drink into PMG. Any waste should be disposed of in our garbage and recycling bins. Litter may damage the art.
- Scheduled group tours may request to bring meals to enjoy here for an additional \$1/person.
- No alcoholic beverages are allowed during normal business hours. PMG hosts a number of private and public events where alcohol is permitted.

#### SMOKING/DRUGS:

- PMG is a tobacco-free environment. Please refrain from chewing or smoking tobacco on the property. Anyone caught violating this rule will be asked to leave the premises.
- PMG is a drug-free zone. Visitors found consuming illegal substances will be required to leave the premises.

#### PETS:

- Child/dog friendly dogs and service animals are allowed at PMG. We ask that you keep your pet on a leash and clean up after them.
